A+ PRACTICE FEE ALL A+ INDIVIDUAL FEES

Total A+ membership fees are calculated by adding the appropriate **A+ Practice Fee** to the total of all **A+ Individual Fees** for eligible staff in the practice. (e.g. Sole practitioner fee is calculated as follows: Rate 1 Practice fee + Member level 1 fee (\$192.50 + \$136.26 = \$328.75 per quarter or \$1,315 per annum).

Notes:

1. A+ Membership is only available to Australian based practices and all fees include 10% GST
2. A+ fees are payable quarterly in advance
3. A+ Practice Fee is based on the total number of membership eligible professional staff in that practice
4. Membership eligible professional staff include all registered architects, all architectural graduates and allied professionals with a qualification related to the built environment, who are also working in the practice for a minimum of 3 days per week.
5. Practices of six or more eligible staff and those with multiple offices qualify for discounts on the above rates*. If you have offices in more than one state or territory and/or you have six staff or more within one office, please contact membership@architecture.com.au for a detailed quote.
6. To be eligible for A+ membership, a practice must first meet all requirements of the relevant Architects Registration Board for architectural practices (if any).
