RELEASE OF THE TERMS OF REFERENCE FOR THE PROPOSED ALTERNATIVE DISPUTE RESOLUTION SCHEME FOR INDUSTRY CONSULTATION

I am writing to seek input from your association and its members to influence and shape the terms of reference (terms) for the State's proposed Alternative Dispute Resolution (ADR) Scheme for parties involved in the installation of combustible cladding.

Since 2017, and following tragic global events, the Victorian Government's response to the installation of dangerous combustible cladding has involved the Department of Environment, Land, Water and Planning (DELWP), the Victorian Building Authority (VBA) and most recently Cladding Safety Victoria (CSV). CSV are currently delivering a \$750 million Cladding Rectification Program, the aim of which is to remove dangerous combustible cladding from the highest risk residential and government buildings.

The Victorian Government intends to seek to recover the funding expended for the Cladding Rectification Program and has made amendments to the *Building Act 1993* to facilitate the recovery of costs where CSV has funded cladding rectification. The Victorian Government is aware of the serious impact that this has had across the Victorian community and in parallel continues to improve the regulatory framework to restore confidence in the building industry for both consumers and building practitioners.

An important step in recovering costs and improving practitioner behaviour, is to take action against practitioners that have been responsible for the installation or use of non-compliant combustible cladding. The State is proposing an ADR Scheme that provides an opportunity for parties involved in the installation of combustible cladding to voluntarily come together, in a without prejudice environment and assisted by a skilled conciliator, to arrive both more economically and expeditiously at a settlement outcome. The scheme is intended to support Government to pursue claims against parties responsible for the installation of non-compliant combustible cladding as an alternative option to traditional litigation.

Before implementing the Scheme, the Government will shortly seek input from industry stakeholders and participants who are likely to be involved in responding to claims, about the draft terms for the ADR Scheme.

The draft terms, accompanying guidance and process map will shortly be released to seek feedback from key industry groups. You are encouraged to review the terms of the scheme and discuss with fellow members of your industry association.
