




Member Survey Responses - 30 responses 14 Apr-5 May





Member Survey Responses - Impact of COVID-19




Is COVID-19 impacting your practice? 37% Yes significantly 63% somewhat

Member Survey Responses - Business Health




- Revenue losses: most are less than \$1m
- 10 respondents have reduced hours
- Avg 1 day per week
- 30% can hold on 2-4 months
